I accept responsibility for any damage or harm the above-named participant causes to any other participant or person or to the property of the above-name entities and associated persons. **NEW REQUIREMENT FOR MUNA 2020: Counsellors who have student delegates staying in dormitories at CMU are also required to stay at CMU as student supervision is not provided by MUNA-WPG.** Overnight building security is provided in the student dormitories by a professional security company.

In consideration for permission to participate in the MUNA-WPG and related activities (including the provision of lodging and transportation) that take place prior to, during or after the event, for each of us and ourselves, as well as our heirs, executors, administrators, successors and assigns, **HEREBY RELEASE, WAIVE AND FOREVER DISCHARGE** MUNA-WPG, The Rotary Club of Winnipeg, the Canadian Mennonite University, its executives and volunteers, all sponsors and contributors, and all other associates, sanctioning bodies and sponsoring companies and contributing companies and their respective agents, officials, servants, contractors, representatives, elected and appointed officials, successors and assigns (hereinafter the Releasees) of and from all claims damages, costs, expenses, actions and causes of actions, whether arising or to arise by reason of the undersigned's participation in the said event, whether as a spectator, participant, or otherwise, or by reason of the participant's lodging at the Canadian Mennonite University, whether prior to, during, or subsequent to the event.

Participants are not permitted to be under the influence of or in the possession of alcohol, cannabis, and/or illegal drugs at any time during the duration of MUNA-WPG, including the Friday evening gathering off site. Disrespectful, hurtful and hateful communication with fellow participants, including via notes delivered by the Assembly Floor Pages, is not tolerated at MUNA-WPG. There is a zero-tolerance policy for these rules and conduct. Any participant found to be in violation of these rules and conduct will be immediately ejected from the conference, with a full explanation of the event being provided to the participant's advisor. Such participant(s) will be sent home at their own expense.
